

THE-DATE ANNOUNCEMENT

1. The purpose of this correspondence is to announce the dates for The Hornet Recurring International Logistics Review (THRILR) 2019, which will be conducted the week of 1 April 2019. The actual venue for THRILR 2019 is still being determined but plan for the event to be in the St. Louis, Missouri area.
2. During the two steering committee meetings we conducted during this year's THRILR, the members recommended an approach similar to the F/A-18 Technical Coordination Meeting (TCM) whereby specific subgroups be established. In that regard, we are in the process of forwarding a survey to determine the composition of subgroup topics. Once the surveys are returned, we will be publishing a draft agenda that will contain additional information about THRILR 2019.
